Rehabilitation of Port Loko Potable Water Supply System

1. The *Port Loko District Council* has received funds from the Government of Sierra Leone through the Ministry of Finance and Economic Development and now invites sealed bids from eligible bidders for the rehabilitation of the Port Loko Water Supply Scheme. This rehabilitation covers the following::

- **raw water intake including replacement of abstraction submersible pumps; sedimentation tank**
- **pumping station**
- **treatment plant**
- **service reservoirs at Natcom Building and Port Loko Teachers College;**
- **Distribution Networks**
- **Power supply and electrical installation**
- **Stand post connections**
- **staff quarters**

2. Details of these works are indicated in the drawings and described in the specifications and Bill of Quantities.

3. Bidding is open to all contractors in Commonwealth and UN member countries who can demonstrate and provide the following documents with their bids:

- (ii) Certified true copies of original documents defining the constitution or legal status, place of registration and principal place of business
- (ii) Total monetary value of construction work performed for the last five years amounting to an aggregate of US\$2.0 million or equivalent;
- (iii) Experience in the execution of at least one similar water related works in the last five years.

(iv) Evidence of adequacy of working capital for this contract (access to lines(s) of credit and availability of other financial resources);

4. Interested bidders may obtain further information and inspect the bidding document at the address below between 10:00am – 4:00pm Mondays to Fridays. Bidding documents may be purchased upon payment of a non-refundable fee of Le500,000 (five hundred thousand leones) or its equivalent in a freely convertible currency.

8. Bids must be delivered to the address below on or before Friday 7th January, 2011 not later than the deadline of 12 noon to the address stated below. Bids received after this deadline will not be accepted and will be returned unopened to the bidder. All bids must be accompanied by:

- ❑ A bid security of SLL 100,000,000 (one hundred million Leones or its equivalent in a freely convertible currency).
- ❑ A certified true copy of registration with the relevant professional body showing that the bidder is qualified to undertake construction works in the water sector
- ❑ a certified true copy of a valid tax certificate issued by the relevant authority in the country in which the bidder operates;
- ❑ a certified true copy of a valid business registration certificate issued by the relevant authority in the country in which the bidder operates ;
- ❑ a certified true copy of a valid clearance certificate from NASSIT for local contractors
